1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2020-21 was £8.32 per elector.

In 2020-21, the Council made payments totalling £3000.00 under section 137. These payments are included within 'Other payments' in the Accounting Statement.



My audit has been conducted in accordance with guidance issued by the Auditor General for Wales.

Auditor General's report

Audit opinion – Qualified

Except for the matters reported below in my Basis for Qualification, on the basis of my review, in my opinion no matters have come to my attention giving cause for concern that in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislation and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Basis for Qualification

Annual Governance Statement

In my opinion, the Annual Governance Statement is not consistent with the Council's governance arrangements for the year:

- Assertion 3 – Compliance with laws.
The minutes of the Council's meeting of 4 July 2021 record that the minutes of the meeting held on 2 June 2021 were approved. The July minutes also state that an amendment was added to the minutes of the 2 October 2019 'Cllr R Rees Rees-Evans declared an interest in the planning application A190622 and left the room while the application was discussed.'
The minutes of the 2 October 2019 meeting had previously been approved as an accurate record at the Council meeting held on 6 November 2019.
There is no legitimate reason for the minutes of a council meeting to be amended 20 months after the minutes had been previously approved. In my opinion, the amended minutes of the 2 October 2019 meeting are not an accurate record of the business transacted. Therefore, I am unable to conclude whether or not the Council maintains accurate records of its proceedings.

Other matters arising and recommendations

There are no further matters I wish to draw to the Council's attention.


