

Llanrhystud Community Traffic and Transport Update.

Following the presentation to the community in relation to the Traffic and Transport concerns in Llanrhystud eighteen volunteers came forward to form a working party.

After consideration it was decided to break down the project into three working groups to ensure we could tackle the many issues that had been raised as quickly as possible, ensuring that everyone's valuable time was being used wisely.

Three Group Conveners were approached, Emlyn Watkin, Dylan Jones and Sue Ferguson.

The Conveners roles are to ensure the groups stay focused and work to achieve tasks identified by the community as issues, gather data and where necessary request expert advice to enable them to come up with a coherent strategy.

Each of the three Groups have met and are responsible for the following areas.
Emlyn Watkins A487. Dylan Jones B4337 Sue Ferguson Llanrhystud Infrastructure.

We recognise there will be crossover with the groups, and we have held our second meeting where Conveners updated the Group to ensure we are all kept abreast of developments.

David Inshaw has discussed with the Police a speed measurement campaign and the group would like a presentation from the PCSO to understand what we can and cannot do with the system, together for how long it will be available.

The group are also investigating a proposal for a small speed monitor which have been successful in other community projects and record speeds as cars and lorries pass by. There are not data protection issues as the systems only record speeds. These systems could give the community constant flow rates and speeds in locations chosen by the group.

Also discussed at the last group meeting. The development of a Llanrhystud Traffic and Transport Website. This will help ensure that the community stay informed. The working group can share information through a portal on the website to reduce administration.

At this stage all three groups are in the gathering data.

All three groups agree to develop plans focused on: -

1. Short Term fixes
2. Medium Term Advice
3. Long Term Vision
